### 4. Eligibility Criteria

#### A. Driver-cum- Attendant

1. Must be a domicile of West Bengal and preferably a resident of the concerned district.
2. Must have passed Class X (Madhyamik) from a recognized Board/Institution.
3. Upper age limit: **50 years**.
4. Experience in livestock farming/animal handling will be desirable.
5. Must be able to speak, read and write **Bengali**.
6. Must possess a valid Driving Licence.

1. Engagement shall be **purely contractual** and governed by the applicable project guidelines and terms of engagement.
2. Candidates must ensure that they fulfil all eligibility criteria before appearing in the interview.
