19. Apart from subscriptions, Federation shall be collecting fees for all around development of the poultry industry and meet up the recurring expenditure, in the name of Development fees on monthly basis and they are as follows:

- The registered and the registered vehicles shall be issued washing and disinfecting certificate from federation washing station and authorised washing stations and that should be issued by federation or in behalf of the federation.**
- 50% of all of the above charges shall be reimbursed to the traders by farmers dealers and integrators after submitting the certificate by the traders in the doostep of the farms.**

Members in this category having no rights in any election of the federation / no voting right in any meeting. All other condition remains same.

(A) Guidelines for subscription & Payment by the members:

- Associate / Corporate means farms, Company, LLP, Partnership & Co-operative Societies & there SHG Groups & turnover shall be more than 50 Lakhs in a particular financial year.*
- In case of primary members in Associate/Corporate Group/ Category if having their sister concern, there will be no subscription fees for the sister concerns, but development fees shall be payable strictly.*
- Finance committee has been requested to follow up the collection and advice to the office administration regarding collection procedure of monthly donations.*
- District committees have been requested for smoothly collecting the renewal subscription and development fees by the head office (as per criteria) or district as per circular.*
- C.E.O/Dy. CEO in charge and office is instructed for proper follow-up about the collection by the district level team and discuss with the finance committee meeting on regular intervals.*
- Capacity and strength should be re-calculated in every six months, by integration committee in case of Broiler.*
- Members are requested for making payment by bank cheques or direct deposit to our Bank account through bank transfer or by cheque to the district office or online payment.*
- District committee should be carefully handling all the matters without any dispute with the members.*

(B) Additional Guidelines for Fees:

- The state level/District level/Block level president/Secretary of the Federation must be a poultry Farmer as per the constitution of federation and if he is doing trading, then 2/3rd of his income must come from the poultry farming activity. Otherwise, he will be sized from the said post as per constitution of the federation.*
- No development fee is required for Poultry farmers having birds below 10000.*
- Subscription & development fees both to be paid for the farmers those having 10000 and above birds.*
- Subscription means both the monthly subscription and monthly development fees together and no single part collection shall be entertained by the federation.*
- Minimum subscriptions of Rs. 300/- for any members who is holding portfolio of any District level /State level committees and members of any sub-committee of the federation.*
- Any member holding portfolio of any President or Secretary of District level/State level committees or any Executive committee members of state level committee and Chairman and Convener of sub-committee of the federation shall be paying minimum subscription fee of Rs. 600/-. (Exempted for "C" additional category members)*
- Every committee member shall be liable to update their accounts of subscriptions and development fees in every quarter compulsorily.*
- Any further review / Amendment, etc. on the same will be uploaded and can be checked on our official website.*
