8. Any other relevant document supporting the eligibility of the candidate for the post.

Important Instructions

1. Candidates shall report at the venue by the prescribed reporting time i.e **10:00 AM** and the last reporting time is **1:00 PM**.
2. Candidates must produce all **original documents for verification** along with self-attested photocopies.
